A report on the attack carried out by the Bengali settlers on three villages of the tribal returnee refugees in Dighinala 18 May 2001

1. Introduction:

The Bengali settlers in cahoots with military and police pre-meditatively attacked three villages - Shanti-Laxmipur, Kalachan Mahajan Para and Hemabrata Karbari Para - of the returnee Jumma refugees of Chhota Merung Union under Dighinala Thana at 12.30 on 18 May 2001.

2. <u>The reasons of the incident and its description:</u>

- (a) The Jumma people of Chhoto Merung Union, which is situated at the southern part of Dighinala upazila in Khagrachari district, were uprooted from their villages in 1986-1991 and forced to take shelter in the refugee camps in Indian State of Tripura due to communal riots and mass-killings. They were repatriated to CHT under the 16 and 20-point Package Agreements reached between the delegation of the government of Bangladesh and the refugee leaders and under the CHT Accord of 1997. Most of them could not go back to their homesteads and villages due to lack of security and the presence of the Bengali settlers. However, the refugees affected by the said incident managed to go back to their villages. The settlers are continuously trying to uproot them and to illegally seize their homesteads and villages. That is why they have been resorting to various impair ways such as riot, looting, arson, harassment, framing cases etc. against the refugees of the said villages in various pretexts.
- (b) On 14/5/2001 Osman Gani, the VDP (Village Defense Party) commander in post stationed near the Chamrachari Army Camp of Chhoto Merung under Dighinala upazila was attacked and shot dead by a few unknown terrorists while he was on his way to his camp with the salary withdrawn for his men from Sonali Bank, Dighinala Sadar branch.
- (c) On 15/5/2001 centered round the incident, the VDPs and settlers of the areas brought out procession in Dighinala. They threatened the Jumma people shouting slogans like "hatyar badale hatya" (killing for killing).
- (d) On 17/5/2001 a secret meeting was held between the military authority and the settlers' leaders in the Dighinala cantonment. The said incident was committed on the basis of the decision taken in this meeting.
- (e) On 18/5/2001 at 10.30 the settlers organized a meeting in front of the office of the Dighinala Upazilla Nirbahi Officer (UNO). At the end of meeting, they brought out a procession with anti-Jumma slogans along some 1-kilometer long road from the Dighinala UNO office to the Larma Square where Dighinala-Khagrachari and Dighinala-Merung roads meet each other. From there they went 5 kilometers south by trucks and attacked the Shanti-Laxmipur, then Kalachand Mahajanpara 6 kilometers further in the south and finally Hemabrata Karbaripara 9 kilometers further in the same direction. It should be noted that a group of army led by Major Momin of the Dighinuala Cantonment and many police personnel led by Officer-in-Charge (OC) Sagir Ahmed Talukdar and Second Officer Mozammel of Dighinala police station were with the settlers while they were attacking the said villages.

The indigenous Jumma people of Shanti-Lakxmipur village alleged that on arriving of the settlers, police and military at the Shanti-Lakxmipur village, a VDP personnel snatched away a rifle from a police and fired several rounds of bullet aimlessly. Then the settlers started looting and setting fire on the houses of the Jumma people. The OC and Second Officer were watching the activities of the

settlers as a passive onlooker. A group of young Jumma people approached the OC and the Second officer and requested them to stop the settlers from carrying out their activities. Consequently, the OC did nothing except playing his referee.

Similarly, the settlers went away to their homes after looting and setting fire on the houses of Jumma people of other two villages mentioned above. However, they desperately tried to find out and kill Hemabrata Karbari and other four Jumma refugees who are continuing land related cases against some settlers in court.

Later, the Jumma people of Shanti Laxmipur came forward to resist the attack of the settlers. The military blocked, charged with sticks and dispersed some Jumma people of nearby Kabakhali and Pablakhali areas who wanted to come in the spot for rescue operation of the people injured.

3. The amount of damage:

- b) It is mentionable that besides looting of and arson on houses, the settlers beat some people and took away many domestic animals such as cow, goat etc. from the Jummal people of the villages. According to a primary estimation, some Taka 5 (five) crore worth properties were damaged in the incident.
- c) 5 women were seriously wounded in the incident. They were admitted in the Dighinala Sadar Hospital for treatment. They are:

All the culprits were from Betchari and Bibhuti Bhushan Karbari Para under Dighinala upazila.

4. Emergency Measures:

A meeting chaired by Mr. Jatindra Lal Tripura, Chairman, Khagrachari Hill District Council was held on 18 May 2001 at the Dighinala Upazilla Sadar with the local leaders at the presence of Mr. Sudhasindhu Khisa, member of CHT Regional Council, Mr. Raktoutpal Tripura, member of CHT Regional Council, Mr. Ashraful Maqbul, Deputy Commissioner, Khagrachari Hill District, Additional Police Super of Khagrachari Hill District, Additional Divisional Commissioner of Chittagong, DIGP od Chittagong Range. In the meeting, it was expressed that there was a need for maintaining peace and harmony of the area and for immediate supply of cloths of daily use, food and utensils to the affected tribal people. It was also decided to tale immediate and necessary steps through Khagrachari Hill Districts Council apprised the meeting regarding lack of necessary fund in the Council to provide such amount of assistance the affected people.

5. <u>Recommendations:</u>

In the backdrop of the incident stated above, the following measures are recommended for consideration:

- 1) To allocate fund to the affected people for construction and repairing of houses, supply of house materials and compensation for damage of properties;
- 2) To transfer the Jumma police personnel and officials working outside CHT to CHT in the interest of protecting communal riots in the region. And to transfer human resources/man-power, properties and institutions etc. to the Hill District Councils as per its Acts in which it has been stated that the Council will supervise and maintain law and order in the Hill District and work for its improvement including police;
- 3) To take measures for adequate punishment of all involved in this incident;
- 4) To immediately arrest VDP and settlers leaders involved in this incident;
- 5) To form a committee with people representatives under the leadership of a justice for fair and impartial investigation into the incident;

6) To take measures for immediate withdrawal of all temporary military, Ansar and VDP camps with a view to stopping military operation and demilitarization of the administration in CHT.

The Parbattya Chattagram Jana Samhati Samiti (PCJSS) strongly condemns the attack on the tribal people and arson, damage and looting of their houses and properties by the Bengali settlers in league with the military and police in Merung area under Dhighinala Thata in Khagrachari District on 18 May 2001. The PCJSS demands a judicial inquiry into the incident and immediate punishment of persons involved in it. The PCJSS also demands immediate measures for adequate compensation to the Jumma people affected in the incident.

It is notable that VDP Platoon Commander Osman Gani was shot dead by a group of terrorists in Dighinala on 14 May 2001. The Bengali settlers created communal tension in Dighinala area implicating the Jumma people with the incident. They organized a demonstration against the Jumma people on 15 May 2001. In the demonstration, they delivered provocative speeches and shouted slogans like "hatyar badale hatya" (killing for killing) against the Jumma people. On 17 May 2001, the military authority called the settler leaders in Dighinala Cantonment and had a closed door meeting with them there. Next day, on 18 May 2001 the settlers again bought out demonstration shouting anti-Jumma slogans in front of the office of the UNO of Dighinala upazila. From there, the demonstration advanced some one-kilometer long way towards Larma Square in the south. From there, the settlers proceeded towards Shanti-Laxmipur, Kalachan Mahajan Para and Hemabrata Karbari Para by trucks and jeeps. They were accompanied by a group of police personnel and VDPs under the leadership of OC Sagir Ahmed Talukdar and Second Officer Mozammel of Dighinala police station. On arrival of the settlers and police and VDPs at Shanti Laxmipur, a VDP personnel snatched away a rifle from a police personnel and fired several rounds of bullets aimlessly. The settlers then started attacking on the Shanti Laxmipur village and looting the houses of Jumma people and setting fire on them. The police remained passive while the settlers were attacking the village. After this, they attacked and looted Kalachan Mahajan Para and Hemabrata Karbari Para in similar manner. As a result, 42 houses were burnt into ashes and 191 houses were looted and damaged. During the attack, the settlers attacked with sharp lethal weapons and sticks whoever they found in the villages that resulted in five Jumma women injured two of them - Monika Chakma and Panchalika Chakma - of Shanti Laxmipur received serious injuries at their head and other parts of the body.

Later, the Jumma people of Shanti Laxmipur came forward to resist the attack of the settlers. The military blocked, charged with sticks and dispersed some Jumma people of nearby Kabakhali and Pablakhali areas who wanted to come in the spot for rescue operation of the people injured.

Later, the military ordered the settlers, who looted houses of Jumma people and set fire on them, to leave for their houses. In this context, it should be noted that the PCJSS is observing with grave concern that some national dailies widely published some baseless news accusing the Jumma people of attacking the Bengalis and setting fire on their houses. These dailies have even described the incident as a 'Jumma-Bengali clash'.

With regard to the above incident, on behalf of the Jumma people, a memorandum was submitted to the Khagrachari Deputy Commissioner (DC) demanding exemplary punishment of the persons responsible for this incident and withdrawal of the settlers from CHT. But till now, no one of them has been arrested. The PCJSS demands

- 1. To arrest and punish the persons involved in the incident without any delay;
- 2. To immediately conduct a judicial inquiry into the incident;

- 3. To provide the adequate compensation to the Jumma people affected by the incident and medical treatment to the Jumma people wounded in the same.
- 4. To withdraw the temporary military, Ansar and VDP camps and the settlers in accordance with the CHT Accord.
